### CONSENT AND RELEASE

The undersigned, as owner or agent for the owner of the dog or dogs delivered to ROSEWOOD RETRIEVERS, INC. ("kennel") hereby waives, discharges, and releases any and all claims that the undersigned or the undersigned's principal may have against Kennel or its agents, employees, officers or owners, arising out of any claim for injury, disappearance, or death of the dog or dogs delivered by Kennel, caused by or alleged to be caused by the negligence of kennel or its agents, employees, officers, or owners, including any such loss or injury which occurs during the transportation of the dog or dogs to or from Kennel's premises. Kennel reserves the right, but is not obligated, to engage veterinarian services for the benefit of the dog or dogs, the cost of which shall be assumed by the undersigned or the owner of the dog or dogs, if the undersigned is not the owner. Any claim against kennel, its officers, agents, employees, or owners arising out of the provision of veterinarian services, or failure to obtain veterinarian services, is hereby waived and released.

It is understood that the training to be performed by Kennel is designed to enable the dog or dogs delivered to perform certain acts or feats in obedience or in the field for hunting purposes and/or hunting tests and field trials, and that such training as well as transportation, showing, and general care of the dog or dogs presents certain hazards for the dog or dogs. The undersigned acknowledges that he or she is fully aware of the inherent risks in such activities and waives and releases any claims for injury, death, or disappearance of the dog or dogs delivered incidental to such activities. The undersigned also acknowledges that such training may not result in a satisfactory obedient dog, hunting dog or competitively successful dog or dogs at such hunting test or retriever field trials and the undersigned expressly waives and releases any claim against Kennel, its agents, employees, officers, or owners arising from such failure or alleged failure of the dog or dogs to respond favorably to such training.

**THIS CONSENT AND RELEASE SHALL BE EFFECTIVE AS OF THIS DATE AND SHALL CONTINUE TO BE EFFECTIVE AS TO ANY DOG OR DOGS SUBSEQUENTLY DELIVERED TO KENNEL**, unless and until this Consent and Release is revoked, in writing, by the undersigned or a subsequent Consent and Release is executed by the parties.
